

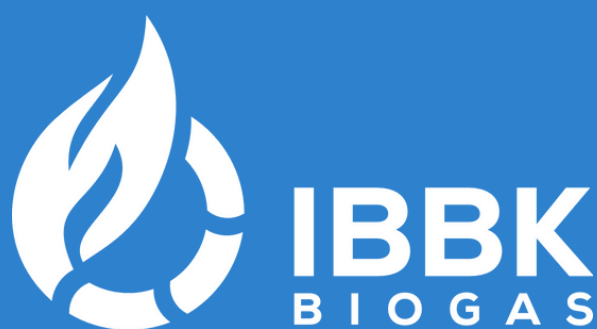

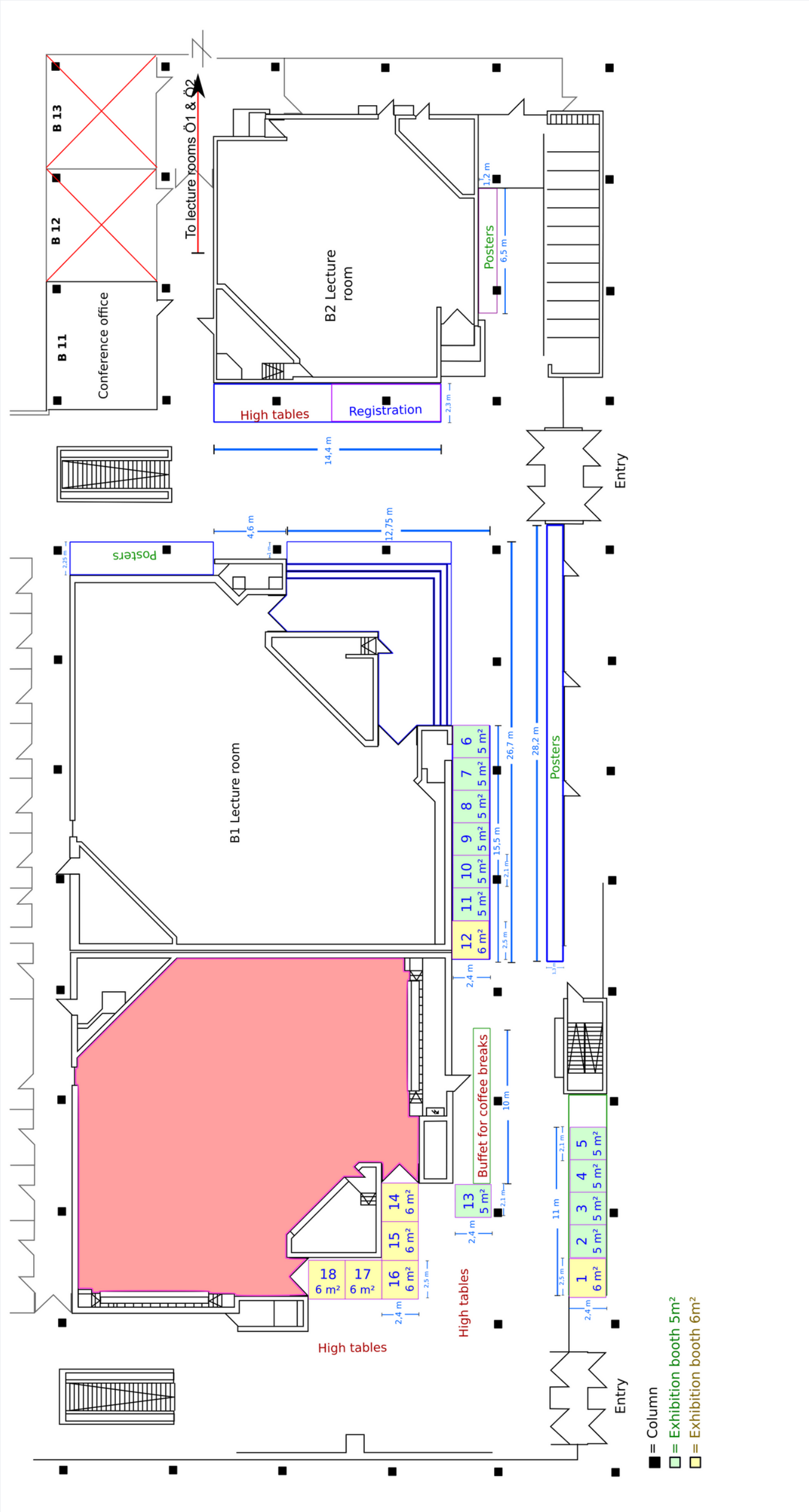

300,00 € per m² + 19% VAT. Starting from 5 m² floor space.

Discount

Special discount of 10 % available for all members of the non-profit organization FnBB e.V. / GERBIO on the regular exhibition fee and sponsoring packages.

By placing the order, the sponsor or exhibitor recognizes all the terms and conditions. The customer must ensure that the persons employed by him at the exhibition also comply with the conditions, regulations and guidelines. The order is binding. The participation fee for sponsors and exhibitors is to be paid within 14 days after receipt of invoice and without deduction.

Stand Size, Equipment, Stand Representative

Exhibitors will book individually the floor space as needed. The exhibition space starts from 5 m². The exhibition space included in the gold sponsoring package is 10 m² and in the silver sponsoring is 5 m². Sponsors and exhibitors must declare their binding stand representative(s).

Each exhibitor gets 1 table, 1 chair and access to electricity. Further required materials - e.g. stand / partition walls, power supply cables, etc. have to be brought by the exhibitors. The registered stand supervisor will receive the same benefits as other conference participants. The terms of participation and business conditions applicable to the conference also apply to the exhibitors and services in connection with the exhibition stands.

Payment Obligations

If the sponsor or exhibitor fails to meet his payment obligations on time, the conference office reserves the right to refuse execution of the contract after a reasonable period has expired. The conference office may make use of the exhibition space in a different manner and claim damages.

Registration Deadline / Contract Withdrawal / No-Show

Sponsors: If a sponsor withdraws from the contract, a processing fee of 990,00 € plus VAT will be charged.

Exhibitor: If an exhibitor withdraws from the contract up to 10 weeks before the start of the event, a processing fee of 300,00 € plus VAT will be charged.

If this deadline is not met, the full exhibition fee will be charged. Stands, which are not visibly occupied on September 2nd, 2024 by 9 am at the latest may be utilized differently. Please let us know in advance if you would like to set up your stand on Friday the 30th of August..

Assembly and Dismantling

The assembly and dismantling of the exhibition stands is carried out by the sponsor / exhibitor or by their representatives and must take place in compliance with the building and fire regulations. Light, junction boxes, cable termination branches for telephone connections and all other connection options, as well as entrances and exits must stay accessible.

Mounting of the stand is possible from 1 pm on Friday the 30th of August 2024 and has to be completed by 5 pm on the same day. The exhibitors could alternatively set up their stand from 7 am until 9 am on Monday 2nd of September 2024. Packing material has to be removed by that time. There is no possibility to store any material during the conference. Vehicles have to be removed immediately after loading or unloading from the loading area. The design of the stand is left to the sponsor in compliance with all contractual conditions. The exhibition booth must be adapted to the overall plan of the exhibition. The stand should be staffed properly and with expert staff throughout the duration of the conference.

Dismantling will take place on Tuesday, September 3rd, from 4 pm and must be finished no later than 6 pm. Prior to the official dismantling date, the sponsor / exhibitor is not entitled to remove exhibition displays from the stand or to start dismantling the stand. The exhibition area is to be left swept clean. Adhesive tapes and similar objects must be removed. Any waste is to be removed by the sponsor / exhibitor after the end of the event. Any cleaning or waste disposal costs are charged to the sponsor / exhibitor.

Liability

The sponsor / exhibitor shall be liable for any damage incurred during the construction or dismantling of the exhibition stand in the facilities of the University of Hohenheim - Stuttgart. The organizer takes no obligation or warranty for property and possession of the sponsor or exhibitor and excludes all liability for damages and loss.

Cancellation of the Event

If the International Conference "Progress in Biogas VI" has to be canceled or postponed for unforeseeable reasons, all paid fees will be refunded. Further claims are excluded. Program is subject to change.

Validity and Jurisdiction

The invalidity of individual clauses does not result in the ineffectiveness of the entire contract. Place of performance for both parties is Stuttgart. Jurisdiction is Langenburg. German law applies.
